
Only the specially tapered **VAULT Key** can pass through this barrier, not allowing standard keys to even engage with the core. That means **you control who gets access, and when**.

There is no need to spend extra money on a new key cutter or combination kit because VAULT is compatible with the standard SFIC service equipment that is already in place, including standard-issue key cutting equipment.

- VAULT, which comes in 7-pin sizes, is an easy upgrade option for current standard SFIC and PDQ systems.
- VAULT cores and keys are BHMA certified
- All current standard SFIC and PDQ interchangeable core housings can be used with VAULT cores, therefore no new or modified locks are required.



Documentation Process

There are 3 different roles within the VAULT certification process.

PDQ


- 1. PDQ will authorize distributors that meet all requirements to sell PDQ VAULT products.
- 2. A Distributor Agreement will be forwarded for signature and will be maintained in the PDQ Key Document Vault.
- 3. PDQ Customer Service will reference all documents from the PDQ Key Document Vault no faxing or emailing of documents is necessary.

Authorized Distributors

- 1. Authorized Distributors assign a Primary Contact and up to 5 additional users when filling out their Distributor Agreement.
- 2. Authorized Distributors sign up End Users that want to buy PDQ VAULT.
- 3. An automated process for sending an End User Agreement is launched and this agreement will be stored in the PDQ Key Document Vault.
- 4. Orders are placed for PDQ VAULT cores and keys referencing the Contract ID of the Letter of Authorization no faxing or emailing documents is necessary.

End Users

- 1. End Users assign a Primary Contact and up to 5 additional users when filling out their End User Agreement.
- 2. A Letter of Authorization for the selected Authorized Distributor is generated and signed by the End User and Distributor.
- 3. Letters of Authorization are stored in the PDQ Key Document Vault and assigned a unique Contract ID.
- 4. If the End User wants to change distributors, they can complete a Transition Notice.
- 5. Orders are placed for PDQ VAULT with their Authorized Distributor.
